The Business Registry processes applications for the registration of sole proprietorship, partnership, companies and other businesses. Laws governing the registration of businesses are the Companies Act, Cap 249 of the Laws of Sierra Leone, (as amended), the Business Names Registration Act, Cap 257, the Business Names 1983 as amended by the Registration of Business Act, 2007, and the General Law (Business Start Up) (Amendment Act) Act, 2007.

However, the office is still not able to optimise its operations, as a result, some companies fail to submit annual returns of their operations, which in turn lead to loss of government revenue.

All businesses in Sierra Leone are required to be registered, and a certificate issued, that must be displayed in the principal place of the business. Businesses may be registered as a sole proprietorship, a partnership, or a company.
