<p>Gianfranco Ferré SpA Company Overview</p>	<p>Gianfranco Ferré is a fashion house which designs men's and women's clothing and accessories, some of which used to be produced and distributed by Italian apparel and textile maker Marzotto, but the agreements have expired.</p> <p>Gianfranco Ferre Spa offers jeans, sportswear, shoes, stationary, luggage, home furnishings, watches, and perfumes. It distributes its products through its stores in Dubai, Beirut, and Istanbul; and a network of boutiques in Italy, the United States, and internationally.</p> <p>Gianfranco Ferré also operates about 40 boutiques for men and women in Italy and 15 other countries. In an effort to extend its reach to new customers, the company has been renaming and reshuffling some of its labels, and uses the name Ferré (dropping the Gianfranco) on storefronts.</p> <p>The company was founded by its namesake designer in 1974 in Milan, Italy. Dubai-based retailing firm Paris Group acquired Gianfranco Ferré in 2011, two years after former parent IT Holding went into administration.</p> <p>As of March 9, 2011, Gianfranco Ferre Spa operates as a subsidiary of Paris Group International L.L.C.</p>
